#### PURPOSE

The purpose of this epidemiological questionnaire is to help the Incident Management Team determine a commercial premises' classification: Contact Premises, At-Risk Premises, or Monitored Premises. Additional information will be considered (e.g., daily PCR testing and production data) when decisions regarding movement permits are made.

A Buffer Zone Placement Epidemiological Questionnaire should be completed with each buffer zone placement biosecurity audit conducted.
